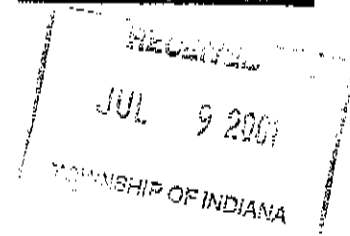

Dear Board of Supervisors:

As concerned area residents who travel the portion of Rich Hill Road that is located in Harmar Township, we are writing to notify you about the dangerous condition of this road. This road has remained in a consistent state of disrepair, and we believe that it now poses a threat to the safety of those who travel on it. In the past few years, traffic has increased dramatically as a result not only of new residential development but also the opening of the Pittsburgh International Sports Complex, which draws hundreds of cars a day during soccer seasons. The brick plant expansion has likewise increased the number of tractor-trailers, which appear to exceed the road's weight limit, using the road.

The road is riddled with potholes, craters, and bulging asphalt patches. It narrows at points, creating dangerous blind curves. Drivers are often forced to leave their lane to avoid the road's hazards. Increased traffic has increased the incidence of near collisions between vehicles traveling in opposite directions and trying to maneuver around the hazards.

The condition of the road has caused property damage but more importantly creates an unacceptable risk of personal injury to our neighbors and children. Many school buses use this road as a bus route, and we are concerned for the safety of the children riding in those buses.

We are attaching to this letter a petition signed by concerned residents of Shawnee Ridge and Rich Hill Estates. It is our hope that you will take immediate and positive action to alleviate the danger caused by that portion of Rich Hill Road located in Harmar Township. Because we believe that concerted action is necessary, we are sending a copy of this letter to the Indiana Township Municipal Office and the Fox Chapel Area School District. Thank you in advance for your attention to this matter.
